The mission of Big Brothers Big Sisters of Northern Nevada is to create and support one-to-one mentoring relationships that ignite the power and promise of youth. In 2020, that mission only became more urgent as our kids adapted to a new way of life. Now more than ever kids in our community need mentors to defend their potential. In 2020, 100% of age-eligible Littles graduated high school, compared to 78% of their peers of similar socio-economic background countywide. During 2020 BBBSNN served 458 children throughout Northern Nevada of which 61% were Hispanic. We saw incredible outcomes for our youth academically with more than 96% of our kids maintaining or improving their grades. In addition we made sure that every child in our program avoided involvement with the juvenile justice system and 93% of our Littles
